EARTH DAY CLEAN UP

The 40th Anniversary of Earth Day is April 22. **Our Earth Day clean up will take place on April 17th at two sites this year, Jamestown and Sharon PA.**

In Sharon we will be working to remove litter along the riverbanks near the Budd Street Canoe launch, Bicentennial Park, and other sites along the Shenango River as we are able. We

will meet at the blue tent in the plaza parking lot downtown Sharon and get to work at 9:00 AM. We will wrap it up around noon with pizza being provided by Marchelloni's.

Our effort in Jamestown is a continuation of a dump removal we began in 2008. This site has been radically transformed in the last two years; however, like many big projects there is more that can be done. The clean up work will take place along the abandoned railroad bed where the Mercer County Trails Association plans to build a bicycle trail. The location is just off of Route 322 in Jamestown behind the Jamestown Paint Company. Again, the work will get under way at 9:00 AM and we hope to finish around noon or so.

Since we're split between towns, we can use all the help we can get. If you can help us out on April 17th please drop us an e-mail or call the office so we can plan accordingly.

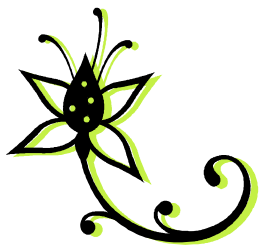

TIRE RECYCLING DAY

Earth Day Clean Up – A nuts and bolts perspective

Earth Day is an important day to promote environmental awareness for most individuals and organizations with a mission to protect our environment. The Shenango River Watchers are no different. Protecting the environment is central to our mission “To restore and protect the environmental, scenic, and recreational attributes of the Shenango River Watershed “. The fact that Earth Day celebrates its 40th anniversary this year and is still recognizable and relevant is good news for us all. But that’s not the gist of this piece.

For me, I’ve been cleaning up for a bunch of Earth Days. I have no speech or inspirational message to share in this text. This is the “nuts and bolts” perspective I mentioned. Earth Day is fixed on April 22 each year. For practical purposes at SRW we like to work a clean up event on the Saturday as close to April 22 as possible. In the Shenango River Watershed this is unique time of year that has no equal on the calendar for a land-based clean up, and that gets me inspired.

Here’s why. Cleaning up the watershed is highly rewarding, but anybody who’s worked with us knows that it can be a lot of hard work. The generally mild temperatures we get in our

area in April are welcome for a day of hard work. In most cases April has the trees largely naked and the ground cover can be sort of thin and brown. It’s not the scenery we may prefer to look at, but for a clean up, it’s fantastic. Getting around without everything all grown up is much easier, and the visibility to see the trash that may need rounded up is unmatched to any other time of year. Add a couple of weeks and everything becomes hidden. One particular item we don’t see much of in April (and I don’t miss) is poison ivy. This lets us tread places we might have to skip in the summer. Also, most of the bugs, and especially the ones that bite (mosquitoes, bees, deer flies, etc.) are not in high gear yet. April is just plain perfect to do this work.

One thing that doesn’t work so well around Earth Day is a canoe clean-up event. The water is usually a little high and a little colder than I like to slop around in, but there is plenty of summer to get into that.

Symbolically, Earth Day is important to us. From the world of Clean Up and Recycling in the Shenango River Watershed, it’s the perfect time of year!

Repeal Day Beer Tasting Again Benefits SRW

On December 5th 2009, over three hundred people gathered to celebrate Repeal Day for the third time in the Shenango Valley since 1933. The event was sold out. Repeal Day, the anniversary of the repeal of the 18th amendment to our constitution, marks the glorious end of a 13 yearlong ban on the manufacture, sale, and transport of alcoholic beverages in the United States. The event was a beer taste benefit held at The Corinthian, a renovated Masonic Lodge circa 1910 with Victorian woodwork and other architecturally correct details in downtown Sharon. This was the perfect spot to slip on your best retro garb and sample some sixty craft beers and to sample food. Music for dancing and listening was provided by the sounds of Max Schang and Bathtub Gin Swing. Actors from the local arts guild the Walnut Lodge appeared as Mae West, F.D.R., as well as a small group of protestors playing music for food. A silent auction with beer paraphernalia organized by River Watchers raised additional

funds. Best of all, the event organizers, the Brotherhood of Appreciating Repeal Day (B.O.A.R.D.) selected the Shenango River Watchers to be the beneficiaries of the proceeds. The event raised \$5,000 for the River Watchers. The Brotherhood of Appreciating Repeal Day is a loosely affiliated fraternal organization founded by a small group of friends who enjoyed good beer and good times with a higher goal to make Repeal Day an annual celebration with a noble cause. The group's monthly meetings serve as a social outing as well as an operational meeting, often times less of the latter. The idea is to have fun while promoting the objectives according to the founding resolution, "to fuel the ongoing appreciation, respect, and passion for quality beer and to celebrate, as its high-water mark, the annual observance of Repeal Day in this fair Shenango Valley, western Pennsylvania, and eastern Ohio." By making the event a benefit, the group would raise funds and awareness for worthy community organizations. The B.O.A.R.D. chose the River

Watchers since good beer requires clean water!

The event received national exposure with an article in Wine Enthusiast magazine. The response to the event was overwhelmingly positive. Representatives from Vintage Estates Beer & Wine, M&M Beer, Erme's, Vecenie, and Glenwood distributors, as well as the Blue Canoe, Yuengling, Erie, North Country, Great Lakes, Rust Belt, Straub, and Voodoo Brewing Companies were personally on hand to pour and discuss the beers being sampled. All the beer products were gratefully donated.

Repeal Day 2010 will mark the 77th anniversary of the repeal. Plans are underway to make it the best yet with proceeds again supporting the Shenango River Watchers.
